## PREFACE

This finding aid covers 66 volumes of assorted government ledgers dating from as early as 1894 to 1962. they have been categorized to facilitate research under the following headings: Territorial Court, 1899-1919; Professional Registers, 1898 – 1950; Gold Commissioner, 1900- 1907; Crown Timber & Lands Agent, 1894 – 1962; Comptroller, 1910 – 1951; , 1910 – 1951; Yukon Mail, 1906 – 1908; and Miscellaneous, 1909 – 1946 – items which did not fall under any of the other headings.

The ledgers in this collection were each given a location number. A description of each volume which follows the index should give sufficient information to enable researchers to decide if a particular volume contains information they are interested in.

## SERIES 8 – INTRODUCTION

Series 8 is a collection of miscellaneous files and ledgers that have been deposited in the Yukon Archives.

There are 70 volumes of assorted government ledgers dating from 1894 - 1962. The ledgers have been numbered consecutively and have a separate finding aid.

There is only an inventory listing for the miscellaneous files, 1897 - 1972.

The subjects covered in Series 8 are diverse and include such topics as: Territorial Court, professional registers, the Gold Commissioner, Crown Timber and Lands Agent, Comptroller, Yukon mail, squatters, blueprints of Commissioner's residence in Dawson, Yukon Council, mining claims, N.W.M.P. - Forty Mile Detachment weekly reports, Yukon administration chart, and other topics equally interesting but too numerous to list.
