SERIES 7: CENTRAL REGISTRY FILES – INTRODUCTION

Most files in Series 7 have central registry numbers while some bear file numbers from another numbering system. They were received in the Yukon Government's record centre in 1972 but where the records were kept before that date is unknown.

Subjects included in this series are: applications for creek claims, quartz claims, dredge leases, water applications, proclamation re: division of mining districts, Yukon Council Ordinances, Dawson City Charter, Bylaws and Ordinances, Dawson Public library, Dawson City assessor and tax collector, Dawson Community Club, government appointments, waterfront leases, information on mining recorder's offices, attendance reports, land applications, financial reports of various departments, individuals tax files, care of insane, examination and transfer of deceased persons, incorporation of companies, Gold Commissioner and Territorial Court cases, R.C.M.P. case files, marriage license correspondence, miscellaneous Commissioners' correspondence, Yukon Bar Association, Territorial Secondary Law Examinations, Civil Service Commission, Temporary National Service Selective Offices, letters requesting information about the Yukon Territory and replies, and other miscellaneous files.
