History of the Game Department

As early as 1902 the Yukon Council passed an Ordinance intended to help preserve the Territory's game. Responsibility for game preservation lay directly with Yukon's chief executive (first the Commissioner, later the Gold Commissioner, and still later the Controller). This continued to be the case until the late 1940's.

The influx of armed forces personnel during the Second World War placed heavy pressure on Yukon's game resources. The Territorial Agent in Whitehorse played an increasingly important role in administering game regulations and policies.

In 1949, unfavourable publicity in "Look" magazine focused on the poor enforcement of Yukon's game legislation. Later the same year Them Kjar was brought in from Alberta to serve as Director of the newly formed Game and Publicity Department. This department's responsibilities centred on the development and administration of a game policy for the Territory. This included supervising guide / outfitters, licensing trappers, collecting fur export taxes, issuing hunting licenses, and controlling predators.

The Department of Game and Publicity was officially established by a 1951 amendment to the Public Service Ordinance. In 1953, the publicity function was dropped from the department's title, a function that never seems to have comprised much more than corresponding with sportsmen outside Yukon.

The department grew steadily during the post-war period. In the year of its inception it was voted a budget of \$12,000. By 1971 its budget stood at more than \$101,000. In 1972 the Game Department was merged with the Department of Travel and Information, and the Yukon Regional Library, forming the Department of Tourism, Conservation and Information.

History of the Records

Most of the records in this series date from the time of the Game Department's creation in 1949, up to its incorporation in the Department of Tourism, Conservation and Information twenty-three years later. The files, in almost every case, were un-numbered and were maintained outside the government's Central Registry. An alphabetical / subject system provided the organizational basis for the files.

This series of records was received at the Yukon Archives in May 1982, through government record scheduling channels. They arrived in record boxes, stored in a manner that confirmed they had been organized alphabetically when last in use. When received, the records occupied 5.33 metres of shelf space. Over a period of three months, the records were appraised, selected, arranged and listed. Their bulk was reduced to just under two metres. The following criteria were used to select materials for permanent retention:

- to document the policy and decision making processes of the Game Department;
- to document the growth and development of the Game Department, as well as its changing roles, procedures and functions;
- to document the department's management of the game resource, and the history of industries based on this resource;
- to document activities in remote Yukon districts.

For archival purposes, these records have been arranged in five parts. The first part consists of the department's alphabetical / subject files. The second includes the Director's out letters, and the third part comprises a set of wildlife maps. A sampling of departmental outfitter files, and a sampling of enforcement officers' occurrence reports constitute the last two sections of Series 9.

A notation appears in the listing wherever sampling was employed to reduce the bulk of a group of files. This was most often used when files covering a period of several years contained similar material judged to be of low informational value. Generally an attempt was made to retain materials from each year represented, and to retain materials reflecting the annual flow of work. The outfitter files, however, were subjected to random sampling, with one file in five being retained.

File titles are, for the most part, those that appeared on the original file jackets. Descriptions of files are usually those that were prepared by the department when the records were inventoried.

For further information on the original arrangement of these records, the researcher is referred to Vol. 2 File 12 in this series, which deals with the Game Department's internal filing arrangements.

RESTRICTIONS

For reasons of personal privacy, the sampled Outfitter Reports and the Occurrence Reports have been restricted. They will be made accessible to the public thirty years from the date of closing of the most recent file in each section. For the outfitter Reports this will be 2009, and for the Occurrence Reports, 2007.

OTHER SOURCES OF INFORMATION

Information on game regulation and management is contained in several Yukon record series. Foremost among these is Series 3 in Yukon Records Group I. This contains the main run of records pertaining to fish and wildlife matters from the period preceding the establishment of the Game Department, and is an invaluable source, covering the years 1898 – 1950. Some other files from Yukon Record Group I concerning game management include the following:
