SERIES 5: WHITEHORSE AGENT – INTRODUCTION

Series 5 was transferred from the basement of the Federal Building in Whitehorse to the Yukon Archives by Tom Retallack who was working with the Federal Lands Office.

The files in this series are apparently the records of the Government Agent in Whitehorse who reported to the Commissioner. These files are definitely not part of the Central Registry series of files. The Government Agent acted as the Mining Recorder, Land Agent and Territorial Agent and his files had their own numbering system.

Subjects included in this file series are: land applications, hay permits and grazing applications, fishing licenses, commission to be paid to police, Indian reserves, applications for coal lands, waterfront leases, information on government employees, correspondence re: railway to Dawson, list of N.W.M.P., old Whitehorse Cemetery, dredging leases, stamp register, Hootalinqua books and papers, Indian School at Carcross, mineral claims, Miles Canyon Water Power - Yukon Smelting Co., law stamps, water rights, White River Records, repairs to Fire Hall, South African Volunteers - Land Certificates, Fox Farm statistics, B.Y.N. Co. - Central Dam on Lewes River, agricultural possibilities at Kluane, correspondence with mining recorder offices, quartz crown grants, annual general reports, live ammunition firing and operations dangerous to the public, maps and distribution, general information on timber and land, companies - general, operating in the Yukon, and other miscellaneous topics.
